## **NOTES FOR APPLICANTS**

### **1. APPLICATION FORM**

- 1.1 The application form is to be supported and sent through your office (if applicable)
- 1.2 The application form is to be accompanied with the appropriate term membership fees which are listed below. The cheque payment should be made payable to "SIA Group Sports Club"
- 1.3 There are three tenures of Associate Term Membership:
  - a) A 1 year Associate Term Membership for a designated period of one year at \$1800 per year and renewable upon application subject to approval from the Club
  - b) A 3 year Associate Term Membership for a designated period of one year at \$2700 per year and renewable upon application subject to approval from the Club
  - c) A 5 year Associate Term Membership for a designated period of one year at \$3900 per year and renewable upon application subject to approval from the Club
  - d) Associate Term Membership fees cover all monthly subscriptions and fees for family membership inclusive of children. Please note that children below 18 years of age are considered family membership and will be allowed the use of the Club facilities if accompanied by Parents.
- 1.4 In the event that an applicant withdraws his application after it's been approved and provided that the applicant has not yet received their membership cards from the SIA Group Sports Club, the necessary application fees will be refunded accordingly.
- 1.5 In the event that the application is not approved by the SIA Group Sports Club then the fees will also be refunded.

### **2. CHILDREN AS FAMILY MEMBERSHIP**

- 2.1 Members whose children are above 18 years of age and below 26 years may apply for Junior Membership at the prevailing monthly rate of \$5 for their children provided they are in Full Time National Service or attending Full Time in recognized education institution.

### **3. PROPOSER**
